Based on the *Race, Religion, and Justice Project, the most comprehensive study of evangelicals and race in over twenty years, *Faithful Antiracism: Moving Past Talk to Systemic Change* challenges Christians and the church to deepen their discussion on racial righteousness and the value of discipleship.


Christina Edmondson and Chad Brennan address the lingering questions around racism and cultural bias in local congregations, denominations, and other Christian institutions. Drawing from this new research, Brennan and Edmondson untangle the practices, theology, history, and social political ethics surrounding America's persistent racial stratification. And they tackle questions such as:

- How do we determine if we ought to label an organization or system racist?
- What are the appropriate and most efficacious interventions in such spaces that bring to bear the special revelation of God's Word and the common grace of the social sciences to address it?
- What resources within the history, theology, and liturgy of Christianity do we currently have that are being overlooked?
- How do we strategically, correctively, and biblically challenge those individuals and systems most resistant to the call of divesting from racist practices and ideologies in the name of Jesus?

*The Race, Religion, and Justice Project (RRJP), directed by Chad Brennan, was a two-year national research project that took place from 2019–2020. It was a collaboration between the Barna Group, the Racial Justice and Unity Center (a ministry of Renew Partnerships), lead researchers Drs. Glenn Bracey and Michael Emerson (coauthor of the book *Divided by Faith*), and the Lilly Endowment. The RRJP was one of the largest studies of racial dynamics in US Christianity ever conducted. It consisted of interviews with 115 leaders and experts in ten cities, a nationally representative survey of 3260 individuals, focus groups with 119 congregants in seven cities, and ethnographic studies of churches in four cities. Imagine if we could work together across racial, ethnic, and cultural lines to address the major challenges we and our children will face in the coming centuries.

Even if we don't arrive at the top of the mountain within our lifetimes, every step we take toward the summit is a step away from evil, pain, confusion, and conflict and toward Christ's peace, healing, truth, and love. We are excited to journey with you.


